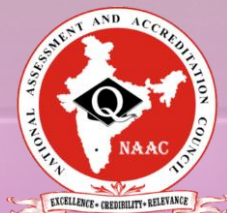

NOTE - When deciding on the licensing of posts as per Government Decision Date 3/11/2018, it is being pointed out that the permissible posts are not excessive as the review of the posts has not been finalized.

1. The workload has been made permissible in view of the granted faculty / division / subjects working in the college and the number of students admitted.
2. It is mandatory for college to maintain number of students on roll as mentioned in proposal for sanction of Faculty/division/subject.
3. The number of students required for grant and maximum number of students should be taken into account for calculating workload.
4. For practicals, a batch of student numbers prescribed by the government decision is compulsory
5. The lectures required for theory / practicals / tutorials / project work are in accordance with the rules prescribed by the government
6. The reservation point list is required to be certified by the prescribed authority as per the prevailing reservation policy of the government as per the stipulation given to the college
7. In the next academic year, the workload will be reduced in case of decline in student strength or other reasons.
8. In case of irregularities in the appointments of such licensed posts, according to the prevailing policy of the Government under the licensing terms, the appointment should not be made without the prior approval of the Government. The responsibility of irregular appointments will be the responsibility of the concerned management and the college. Posts are sanctioned as per the workload granted to the college.
9. Based on the qualifying assignments of the college grants have been made licensed. For recruitment to the licensed posts, it is necessary to submit a non-certification certificate by submitting proposals in accordance with the prevailing policies and procedures of the Independent Government.
10. The expenditure on the salary of the Assistant Professor of this subject shall not be allowable unless the Government has been approved under the commitment of the sociology subject.

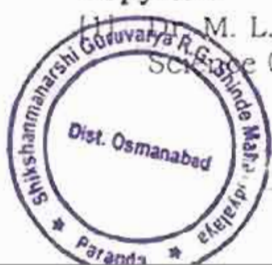

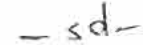

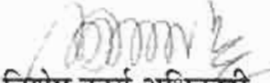
